Commissioner Solid asked about Miron Pesocani accumulated 147 payroll hours over two weeks, to which Frank replied that It is because he is working multiple functions each week, including summer camp counselor, and building supervisor. President Tichacek expressed concern that he will go over his limit of work hours and it will affect IMRF, to which Frank Explained that Miron will be staying under 1,000 hours.
