VII.NEW BUSINESS

1. Discussion and Action on the Summit Park District continuing to have wrestling events.

Discussion: Frank Torres announced that Andrew S. Paine of Tressler LLP had been invited to participate in the discussion On wrestling events, serving/selling liquor and obtaining liquor licenses. Commissioner Solis had previously posted Questions regarding the liability issues, but she is absent today. However, Commissioner Ponce is also concerned about the Liquor licenses, which he had previously mentioned at a board meeting held 15 months ago. He is concerned about the liability for the park district is something bad happened involving persons who had been consuming alcohol on the park district grounds.

Andrew S. Paine recommended that the board establish an official policy about selling alcohol during park district events. This policy should include requirements that the park district carry ram shop (liquor liability) insurance, as well as schedule A BASSET-certified individual at each event to inspect pieces of identification for those purchasing alcohol. These actions will reduce the park district's liability and keep preventable lawsuits at a minimum.

In addition, Andrew S. Paine recommended that the policy make a provision for vendors who wish to sere alcohol. These vendors can acquire their own license, which is particularly easy for established restaurants and bars, who already have Licenses for their own business sites. The mayor's office can issue a special one-day event license for this purpose, or the business can temporarily transfer their existing license to the special event. However, vendors who have never obtained liquor licenses before many find it more difficult to get one through the normal application process and channels. This Approach would effectively shift all liability to the vendor, assuming they have proof of insurance and a liquor license. Andrew S. Paine asked the board if they wish to serve alcohol at special events and whether they want the responsibility For liquor licenses to be held by the event organizers or the vendors.

Frank Torres asked Andrew S. Paine that, if the park district obtained a liquor license, would another organization such as Mega Events, be able to serve alcohol on park district grounds without their own license or proof of insurance.

Mr. Paine replied tat the park district could do it this way without extending their liability. The park district could also list this as part of their available services and charge accordingly I tits fee structure, Frank added that the park would then control the licensing and insurance but would also be responsible for keeping BASSET-trained servers at these events.

President Tichacek requested a motion to approve the Summit Park District to continue having wrestling events, acquire a one – year liquor license, serve liquor at theses events and to charge the organizer \$1,000 in associated fees.

Andrew S. Paine announced that the two individuals discussed today, Guillermo Islas and Miron Pesocani are in a protected class due to their minority status. He is not aware of the reasons for Miron's dismissal. Frank relied that was an incident where Guillermo and Miron came upon the park district grounds finding that the garage door was open with the lights on, there were gates wide opened in the maintenance yard, and the soccer field lights were on. They both proceeded to turn off the lights, close the gate and garage door, and then brought a number of friends to play basketball together in the gymnasium. Andrew stated that these are proper grounds for termination, but since it is the first offense for both, perhaps a formal reprimand would be more appropriate. President Tichacek added her opinion that both employees should be offered the chance to continue their position on a probationary basis pending further evaluation. In addition, she recommended that each of them keeps their positions only if they write a letter of apology to the board.

Frank closed out the discussion stating that this would be the last chance for these employees. If they commit any further Infractions, they would be immediately terminated.

President Tichacek stated that this topic will be tabled until further notice.
