3. Financial report given by GW & Associates was not given today, but Executive Directive Frank Torres asked the board to review the budget and promptly provide him with any questions ahead of the public hearing on the public hearing on July 9, 2019. President Tichacek pointed out the General Fund Expenses for Year End April 30, 2010, which is on page 12 of the tentative budget for 2020 inside each commissioner's Board packet. She pointed out that Travel, Meeting, and Conferences have been assigned a budget of \$500.00 which is far below what this expense totaled last year. Frank replied that the actual number should be \$5,000.00 and that he would make sure that it was corrected.

President Tichacek mentioned how the Membership Dues at listed at \$3,500.00, which Frank explained is the Number that is paid every year. She also asked about the total of \$15,000.00 in the Office Supplies and Office Equipment/Furniture categories where the park district only budgeted \$10,000.00, along with the expensive uniform budget. Frank replied that he has established a new contract with the uniform company and the fees will wee a significant reduction. He added that a special meeting with Dave Gonzalez of GW & Associates should be held to get a breakdown of what is in all the park district's accounts.

Commissioner Santoyo inquired about funds for the Summer Public Library, to which Frank replied that funds are sent each year for the library's reading programs. President Tichacek also confirmed that the park donates money to the library's reading programs
